A Moot Court is an extracurricular activity in which Law students take part in simulated court proceedings, which usually involves drafting briefs (or memorials) and oral argumentation. A Moot court does not involve actual testimony by witnesses, cross-examination, or the presentation of evidence, but is focused solely on the application of the law to a common set of evidential assumptions to which the competitors must be introduced.

The Businet Moot Court focuses on EU Law and it is a unique opportunity for students to show their talent to be the best litigator in this field. English is the common language.
