BUSINET MOOT COURT

General

A Moot Court is an extracurricular activity in which Law students take part in simulated court proceedings, which usually involves drafting briefs (or memorials) and oral argumentation. A Moot court does not involve actual testimony by witnesses, crossexamination, or the presentation of evidence, but is focused solely on the application of the law to a common set of evidential assumptions to which the competitors must be introduced.

The Businet Moot Court focuses on EU Law and it is a unique opportunity for students to show their talent to be the best litigator in this field. English is the common language.

BUSINET INTERNATIONAL LAW GAME

General

Teams that play the BILG do not represent their University but players/students are mixed so that each group/team is composed of students who study at different institutions and speak a different mother tongue. Groups are usually named after one of the Roman emperors.

The BILG case deals with EU Law or International Law matters and the case has to be solved in one afternoon using online communication and computer apps.

BILG is played in English, thus the assignment and the final documents are written in English and so is the common language for communication.
